## **MEMBERSHIP PREREQUISITES:**

In accordance with Article 3: Membership, of the Mariner's Boat Club Constitution, any male or female of the minimum age of twenty-one (21) years of age, who is a Michigan resident and who is of good moral character, shall be eligible to membership in the Mariner's Boat Club and shall be entitled to all privileges of the Club.

Before admission to membership in the Mariner's Boat Club, the applicant must file a signed and written application for membership stating that said applicant has read the Club Constitution and By-Laws and will endeavor to uphold and further the rules and aims stated therein. Said application shall be presented to the Membership Chairperson accompanied by the written recommendation of two members in good standing and the Board of Directors shall act upon such application at the next succeeding Board Meeting.

## **INSTRUCTIONS FOR COMPLETING THE MEMBERSHIP APPLICATION:**

The following instructions are provided to ensure that all Membership Applications are completed properly, and any request received can be considered in a timely manner.

1. Membership Applications shall be completed and left at the Mariner's Boat Club, **OR** mailed to the following postal address:

2. All properly completed Membership Applications will be considered for membership in the order it was received. In accordance with the Mariner's Boat Club By-Laws, Article 1: Membership (Section 1.01), membership shall be limited to three hundred (300) regular members. If that number has been met, all pending applications will be placed on a "Waiting List", and acted upon once a Regular Membership position becomes available.

3. A check in the amount of \$50.00 made payable to "Mariner's Boat Club" must accompany all Membership Applications. The \$50.00 is a non-refundable deposit that will be applied to your one-time initiation fee of \$250.00 at the time you are notified that your application for membership has been accepted by the Governing Board. If your application for membership is denied, the deposit of \$50.00 will be refunded. Regular Membership Dues are currently \$600.00 per year, payable upon acceptance as a Regular Member, along with the balance of the one-time initiation fee. NOTE: Dues and fees are subject to change by a vote of the membership.
